NOTIFICATION

Dated Shillong, the 24th September 2001

No. PHE. 236 / 98 / 209 : In exercise of the powers vested under Sub-rule 3 of Rule 8 of the Bio-Medical Waste (Management & Handling) Rules, 1998, the Governor of Meghalaya is pleased to prescribe the fees for grant of Authorisation for an Occupier/Operator in the following manner, namely :-

A. OCCUPIER

Hospitals, nursing homes, clinics, dispensaries, research and pathological laboratories, blood banks, slaughter houses and research laboratories generating, collecting, receiving, storing, transporting, treating, disposing and/or handling bio-medical wastes in any other manner:

(a) with less than 50 beds	Rs. 1,250.00 per year
(b) with 50 beds and above but less than 200 beds	Rs. 3,750.00 per year
(c) with 200 beds and above but less than 500 beds	Rs. 6,250.00 per year
(d) with 500 beds and above	Rs. 12,500.00 per year
(e) Government Dispensary	Rs. 625.00 per year
(f) Private Clinics and Pathological Laboratories:	
(i) Number of patients or samples upto 5000 and less per year	Rs. 312.50 per year
(ii) Number of patients or samples upto 10,000 but not less than 5000 per year	Rs. 625.00 per year
(iii) Number of patients or samples upto 20,000 but not less than 10,000 per year	Rs. 1,875.00 per year
(iv) Number of patients or samples more than 20,000 per year	Rs. 4,375.00 per year
(g) Number of animals slaughtered upto 5000 and below per year	Rs. 312.50 per year
(h) Number of animals slaughtered upto 10,000 but not less than 5000 per year	Rs. 1,250.00 per year
(i) Number of animals slaughtered upto 20,000 but not less than 10,000 per year	Rs. 1,875.00 per year
(j) Number of animals slaughtered more than 20,000 per year	Rs. 4,375.00 per year

B. OPERATOR

Any other Institution engaged in the bio-medical facility for collection, receiving, storing, transporting, treating, disposal and/or handling bio-medical waste shall apply for Authorisation accompanied by the fees prescribed below :-

(a) Capital investment on above enterprise below Rs. 25 lakhs	Rs. 6,250.00 per year
(b) Capital investment on above enterprise above Rs. 25 lakhs	Rs. 12,500.00 per year
(c) Provided that in case of Government Institution or a local body is engaged in the activities of collecting, receiving, storing, transporting, treating, disposing and/or handling bio-medical waste a token fee of Re. 1/- will be charged.
