PUBLIC NOTICE

It is brought to the notice of all concerned that “**BOULDER STONE MINE**” has proposed Stone Mine over an area of 4.99 Ha. located at Syllai Madan, Laitkynsew, Laitlyngkot Khyrim Syiemship, East Khasi Hills District. The Company has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.

In pursuance to the provisions of Para 7(i) III of the above Notification, the Sub-Divisional Officer, Pynursla, Civil Sub-Division, East Khasi Hills District, Shillong vide letter No. PSD/GEN/17/2017/Pt-II/93/348, Dated 09th July 2024 has fixed the date of the **PUBLIC HEARING** to **BOULDER STONE MINE** to be held at “**SYLLAI MADAN**”, Laitkynsew, Laitlyngkot Khyrim Syiemship, East Khasi Hills District on the **04th September 2024 at 11.00 AM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
