PUBLIC NOTICE

It is brought to the notice of all concerned that “**Daba Saitthad Limestone Deposit**” has proposed Limestone Mine over an area of 25 Ha. located at Daba Saitthad, Lumshnong, East Jaintia Hills District. The Company has applied for prior Environmental Clearance from the Ministry of Environment, Forest and Climate change (MoEF&CC) as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.
