PUBLIC NOTICE

It is brought to the notice of all concerned that "M/s Meghatop Cement Private Limited" has proposed to set up an "Integrated Cement Plant of capacity 3.3 MTPA clinker, 2.8 MTPA Cement and 16 MW Waste Heat Recovery System" at Wahiajer Narpuh, East Jaintia Hills District, Meghalaya. The Company has applied for prior Environmental Clearance from the Ministry of Environment, Forest and Climate Change (MOEF&CC), as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.
