PUBLIC NOTICE

It is brought to the notice of all concerned that **PYDENGSHANGLANG COAL BLOCK** has proposed Coal Mine over an area of 100 Ha. located at Sdad Dkhar Village, Nongstoin C&RD block, West Khasi Hills District. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.
