**PUBLIC NOTICE**

It is brought to the notice of all concerned that **Thanghunai Limestone Quarry** belonging to **Smti. Plenty K. Pyngrope** has proposed Limestone Mine over an area of 3.00 Ha. located at Thanghunai, Nongtalang Elaka, Amlarem C & RD Block, West Jaintia Hills Distrik, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14<sup>th</sup> Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1<sup>st</sup> December 2009.

In pursuance to the above Notification, the Member Secretary of the Meghalaya State Pollution Control Board vide letter No. MSPCB/TB-360/WJHD/1/2024/2024-2025/2, Dtd: Shillong, the 17<sup>th</sup> September, 2024 has fixed the date of the **PUBLIC HEARING** to be held at the project site, Thanghunai, Nongtalang Elaka, Amlarem C & RD Block, West Jaintia Hills Distrik, Meghalaya. on the **17<sup>th</sup> October, 2024 at 2:00 PM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
