PROCEEDINGS OF THE PUBLIC HEARING HELD ON THE 27th September 2011 of the proposed Limestone Mine over an area of 128.52 Ha. of Adhunik Cements Ltd. at Thangskai Village in Jaintia Hills District, Meghalaya

An Environmental Public Hearing in respect of the proposed Limestone Mine of M/s Adhunik Cements Ltd. at Thangskai Village in Jaintia Hills District, Meghalaya was held on the 27th September 2011. The hearing which commenced from 11:00 A.M. was presided over by Shri E. Kharmalki, MCS, ADC, and S.D.O. (C) Khliehriat Civil Sub-Division, Jaintia Hills District.

At the outset, the Chairman welcomed the officers and public present at the Hearing and invited Shri B.B War, Asst. Environmental Engineer, Meghalaya State Pollution Control Board (MSPCB), Shillong to give the welcome and introductory address.

Shri B.B War welcomed the Chairman, the members of the Press, the project proponent and public who have turned up in large numbers to attend the Hearing. He explained that the Environmental Public Hearing has been conducted as per provisions of the EIA Notification, 2006 (14th September 2006) and subsequent amendment E.I.A. Notification No. S.O. 3067(E) Dtd 1st December 2009 issued by the Ministry of Environment & Forests (MoEF), Govt. of India. He explained that the objective of the Hearing is to solicit and record the opinions, views, comments or objections of the people residing in the adjoining areas of the Project site likely to be affected by the establishment of the proposed LIMESTONE MINE at Thangskai Village, in Jaintia Hills District, Meghalaya by M/s Adhunik Cements Ltd.

Further, he explained that the Environmental Public Hearing is a part of the Environmental Clearance process and that no decision on the Project will be taken during the Hearing as its role is strictly confined to recording of opinions, discussions, suggestions submitted in writing or orally so that the same can be submitted to the MoEF, Govt. of India. The Ministry will examine and scrutinize such views, comments, suggestions, etc. regarding the project as recorded during the hearing while processing the application for Environmental Clearance. He also emphasized that the Hearing should not be taken as a platform for any public debate. The views of the public are recorded and filmed. The proceedings are then drawn and submitted to the Ministry of Environment and Forest, Delhi for the Environmental Clearance.

In the Opening Address Shri E. Kharmalki, MCS, Additional District Magistrate and S.D.O. (C) Khliehriat Civil Sub-Division, Jaintia Hills District and Chairperson, EPH, welcomed the Public, the Local Headmen, NGOs, villagers, members of the press and representatives of M/S Adhunik Cements Ltd present at the EPH. He invited those who wanted to speak to submit their names to the staff of the MSPCB and reiterated that speakers should not repeat the views, comments, etc. presented by those who spoke ahead of them.

On invitation from the Chair, Shri. S.K. Baruah, General Manager (Mines) was called upon to give the welcome address on behalf of M/s Adhunik Cements Ltd. He welcomed everyone present and offers his grateful thanks to the local people of the area, District Council and concerned authorities of Government of Meghalaya for their support to the company.

Shri. E. Kharmalki, MCS, Additional District Magistrate, then invited Shri. S.K. Rai, C.E.O., M/s Adhunik Cements Ltd. to present the Administrative & Socio Economic aspect of the proposed project. Shri. S.K. Rai informed that the firm had applied for Environmental Clearance for 128.52 Ha. and stated that the company has obtained all the required NOC's and clearances from different Government authorities and agencies. He expressed that being a new cement plant and in the process of streamlining production and marketing its products, the firm had already done several important social activities such as 1) setting up of a L.P. School with the cooperation of K.J.P. Synod East and Durbar Shnong Thangskai, 2) giving assistance to the Jaintia Eastern College for opening the Commerce wing of the college, 3) providing direct and indirect employement, 4) associated itself for construction of foot over bridge at Jowai for the students of St. Mary Mazerrello High School and Marian Hills High School, 4) giving assistance in encouraging and highlighting the cultural heritage of Jaintia Hills District under the banner of Discover Jaintia every year, 5) organizing medical camps in Jaintia Hills District, 6) appointment of a football coach for the youth of Thangskai Village. Shri. S.K. Rai informed that the company was committed to fulfill the clauses of the agreement made with various organizations and traditional institutions. Moreover the mining plan of the company had been approved by the Indian Bureau of Mines and assured that they will follow all guidelines of the approved mining plan by adopting best practices of mining. He concluded his speech by reaffirming that the company is committed to follow all guidelines of the State Pollution Control Board, District Council and the local authorities.

The same was interpreted in the local language by Smti. Sunday M. Suting Adhunik Cements Ltd.

The Techincal aspect of the proposed limestone mining was presented by Shri. J. Chandramoili, Env Engineer, Envirotech on behalf of the company. He hightlighted that Adhunik Cement Ltd. is incorporated to develop a Greenfield Cement Plant of 1.33 MTPA capacity in the state of Meghalaya and proposed to produce 2.0 MTPA of limestone from the mining lease area of 128.52 Ha to meet the limestone requirement of the cement plant. The Mining Lease area is located at a distance of 1.6 Km-E from the NH-44 and at an altitude of 663 m above MSL and the nearest village is Thangskai which is about 1.2 km from the site. He informs that an Environmental Impact Assessment study for baseline environmental monitoring was carried out during the winter months of 2009-2010 i.e December, 2009 to February, 2010 and the parameters covered were i) Ambient Air Quality ii) Noise Monitoring iii) Water Monitoring iv) Soil Monitoring and v) Ground Vibration Studies. The total water requirement for the mine is estimated to be 30m³/day. The company proposes to take afforestation works over an area of 19.0 Ha of dump area. He also informs that people residing in the nearby villages will be benefitted by direct and indirect employment opportunities which will be created by the mining activity. The company also proposes to establish a well equipped occupational health centre headed by experience doctors and nurses, compunder and pathologist and periodical medical checkup will be carried out. Awareness programmes will be conducted regularly for all employees regarding Aids, Malaria, Filariasis etc. He ended with a note that an amount of R8.75 Crores has been earmarked for the Environmental Management Plan.

The same was translated into the Local Language by Shri.B. Swer.

The Chairperson then invited Shri. B.B. War, Asst. Environmental Engineer, MSPCB, to present the written presentations, comments, etc. received by the Board. The following is a list of the written presentation received:

The presence of the mining plant will pollute the streams and rivers of the area by waste products emanating from the mine. 4) Close to the location of the mining area there are many beautiful caves but the indiscriminate mining of limestone would greatly affect and destroy the caves.

The Public Hearing ended with a vote of thanks from the Chair to all the officials, participants, Doloi and Headmen of different Villages, members of the press and the public present at the Hearing for their co-operation. He also informed that the proceedings of the Hearing will be sent to the MoEF, Delhi for further necessary action.
