## PUBLIC NOTICE

It is brought to the notice of all concerned that **M/S CEMENT MANUFACTURING COMPANY LTD.** has proposed to set up a Limestone Mine over an area of 13.58 Ha. at Village Lumshnong, East Jaintia Hills District, Meghalaya. The Company has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. 


