PUBLIC NOTICE

It is brought to the notice of all concerned that **M/S LAFARGE UMIAM MINING PRIVATE LIMITED** has proposed expansion of its existing 100 hectares limestone mine lease situated at Village Nongtra, Mawsynram Block, Shella Confederacy, East Khasi Hills District, Meghalaya from 2.0 MTPA to 5.0 MTPA. The Company has applied for prior Environmental Clearance from the Ministry of Environment, Forests and Climate Change (MoEF&CC) as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.
