INTRODUCTION

he State Board for Prevention and Control of Water Pollution, Meghalaya was constituted by the Government of Meghalaya on the 16th Day of November, 1983 in pursuance of the first environmental legislation of the country, Water (Prevention & Control of Pollution) Act, 1974. Subsequently the enforcing responsibility of the Air (Prevention & Control of Pollution) Act, 1981 was entrusted to the Board. The functions of the Board are as laid down under Section 17 of the Water (Prevention and Control of Pollution) Act, 1974 and Section 17 of the Air (Prevention and Control of Pollution) Act, 1981. The State Board for Prevention and Control of Water Pollution, Meghalaya was rechristened as Meghalaya State Pollution Control Board in 1988.

Besides the enforcement of the Water Act and the Air Act, the Board is also enforcing the following Acts, Rules and Notifications: -

- 1) The Water (Prevention and Control of Pollution) Cess Act, 1977, and as amended by Amendment Act in 1991.
- 2) The Water (Prevention and Control of Pollution) Cess Rules, 1978.
- 3) The Hazardous Waste (Management and Handling) Rules, 1989.
- 4) The Manufacture, Storage and Import of Hazardous Chemicals Rules, 1989.
- 5) The Manufacture, Use, Import, Export & Storage of Hazardous Micro organism or Cells Rules, 1989.
- 6) The Public Liability Insurance Act, 1991.
- 7) The Environmental Impact Assessment Notification, 2006 and Amendments 2009.
- 8) The Chemical Accidents (Emergency Planning, Preparedness & Response) Rules, 1996.
- 9) The Bio-Medical Wastes (Management & Handling) Rules, 1998
- 10) The Recycled Plastics Manufacture and Usage Rules, 1999.
- 11) The Fly Ash Notification, 1999.
- 12) The Noise Pollution (Regulation and Control) Rules, 2000.
- 13) The Ozone Depleting substances (Regulation) Rules, 2000.
- 14) The Municipal Solid Wastes (Management & Handling) Rules, 2000.
- 15) The Batteries (Management & Handling) Rules 2001.

The Board has been functioning with 66 Staff as on 31st March 2012 against a sanctioned strength of 123. The details of staff position are given in Annexure-1. The organization chart of the Board is given in Annexure-2.



The Central Office of the Board is located in Shillong. At present, the Board does not have any Regional or District Offices. The Central Office is responsible for framing general policies relating to enforcement of the Acts and Rules including implementation thereof. It also looks after the general administration and coordination with other agencies. Besides, it takes up public awareness programmes on matters relating to environment protection and pollution control. The Central Laboratory is well equipped and carries out analysis of samples of water, waste water, stack emission, ambient air, bacteriological tests etc.

The following are some of the main activities carried out by the Board.

- (i) Inspection of industries and local bodies.
- (ii) Monitoring the quality of water and wastewater.
- (iii) Monitoring the quality of ambient air and stack emissions.
- (iv) Inspection of sites proposed for setting up of industries to verify the suitability of the same from environmental point of view.
- (v) Water bodies monitoring under National Water Quality Monitoring (NWQM) Programme.
- (vi) Ambient air quality monitoring under National Air Monitoring Programme (NAMP).
- (vii) Offering guidance to industries and local bodies on statutory provisions.
- (viii) Issue of "Consents to Establish" and "Consents to Operate" in respects of industries, mining projects specified developmental projects and municipal bodies.
- (ix) Waste Management under E.P. Act.:
 - Hazardous Waste Management
 - Identification of Sources
 - Characterisation & Quantification of Wastes
 - Enforcement of provisions of the Rules
 - Monitoring of compliance to standards
- (x) Bio-Medical Waste Management:
 - Identification of Sources
 - Characterisation & Quantification of Wastes
 - Enforcement of Provisions of the Rules

2 CONSTITUTION OF THE BOARD AND CHANGES THEREIN

he State Government nominates the members of Meghalaya State Pollution Control Board. The Board was constituted under Section 4 of the Water (Prevention & Control of Pollution) Act, 1974 vide Notification No. PHE. 161/83/1 dt.the 16th November, 1983. The last reconstitution was notified out in May 1998 vide Notification No. PHE 161/83/178 dtd. the 21st May1998. However, the three non- officials members were refortified vide Notification NO.PHE.161/83/187 dt.the 24th March, 1999 & NO.PHE.161/83/205 dt.the 5th January, 2001.

The Board consists of 17 members nominated by the State Government as per provisions laid down in Sub-Section (2) of Section 4 of the Water (Prevention and Control of Pollution) Act 1974. Besides the Chairman and the Member Secretary, there are 5(five) official members representing various State Government Departments, 5(five) members representing Local Authorities, 2(two) Members representing the Co-operatives and Corporations owned, managed or controlled by the State Government and 3(three) Non-official Members. The list of the Members of the Board is appended at Annexure-3.

During the financial year 2011-2012 Shri M. Allya (w.e.f. 01-10-2010 till date) succeeded as the Chairman and Shri J.H. Nengnong (29-09-2010 upto 14-05-2012) as the Member Secretary of the Board.

The following major decisions were taken during the Meeting: -

55th BOARD MEETING:

- The Board approved the draft concept paper for carrying out the EIA Study of Byrnihat area and decided that the draft paper along with estimate should be sent to CPCB / MoEF for financial assistance.
- ➤ The Board approved the working estimate for the Internal Electrification along with the Central Control Panel at the rate of ₹ 12, 57,164.00 including 5% contingencies to be met from the fund already sanctioned for the purpose.
- ➤ The Board endorsed the action taken by the office of the Board in completing the laying of leased line from BSNL at a cost of ₹ 34,504.00 and purchase of Router from National Informatics Center Services Incorporated (NICSI), Govt. of India at a cost of ₹ 83,827/-.
- ➤ The Board approved the draft "Document on Prevention, Abatement & Control of Water Pollution in Meghalaya" prepared by the office of the Board and decided that the Fisheries Department should be included after which the Document can be finalized and sent to the Govt.
- ➤ The Board approved the proposal to engage Shri K.S. Kynjing, Senior Advocate as the Legal Adviser of the Board at a retaining fee of ₹ 5, 000/- p.m. with fees for other services as per Office Memorandum No. 1 R (B) 1/89/Pt/33 Dtd. 28-03-2000 notified by the Govt. of Meghalaya in Law (B) Deptt.
- The Board approved the Budget proposal (PLAN & NON-PLAN) of Meghalaya State Pollution Control Board for the year 2012-2013 for onward submission to the Govt.



The Board approved the proposal to introduce the Group Saving Linked Insurance for the Board's employees.

56th BOARD MEETING:

- The Board decided that the matter of non-payment of water cess should be reported to the Govt. in the PHED so that it can take up the matter directly with the respective Departments at the Government for realization of cess payable under the Water (Prevention and Control of Pollution) Cess Act, 1977.
- The Director of Commerce & Industries has assured that a concrete proposal for identification of an alternative site for establishment of Common Hazardous Waste Treatment, Storage & Disposal Facility will be prepared and reported back in the next Meeting of the Board.
- Considering the likely impact if boulders quarrying from river beds on the hydrology and ecology of the river, the Board decided that the State Government should be made well aware of the danger posed by such activities including the following views offered by the Members of the Board: -
 - Expert opinion from Institutions dealing with the subject matter on the effect of boulder extraction on the stability of rocks in the river beds and banks of the rivers may perhaps be required before allowing such activity.
 - Stone boulder deposits on the river beds act as natural barrier in controlling the flow velocity of the river thereby preventing erosion of river banks etc. Removal of stone boulders from the river beds will affect its hydrology with adverse impact on the river ecology including aquatic environment.
 - Since there is no provision under the Water Act to regulate such activity, it is advisable that the matter be taken up with the Central Government for regulating such activity under the Environment (Protection) Act 1986.

MONITORING NETWORK FOR AIR, WATER, AND NOISE LEVEL QUALITY MONITORING OF AIR QUALITY

5.1 AIR QUALITY MONITORING

he Meghalaya State Pollution Control Board is monitoring the Ambient Air Quality at 5 (five) stations in the state under National Air Monitoring Programme (NAMP) sponsored by CPCB. The frequency of monitoring is twice a week. Particulate Matter (PM10), Sulfur Dioxide (SO₂), Oxides of Nitrogen (NO_x) and meteorological parameters viz. wind speed, wind direction, ambient air temperature, humidity, etc. were monitored at these stations and the observations are presented in tables below:-

5.2 STATE AMBIENT AIR MONITORING PROGRAMME:

The Board has established an Ambient Air Quality Monitoring station at Umiam Industrial area under State Air Quality Monitoring Programme (SAMP) during August 2009. The objective of the programme is to determine the status & trends of ambient air quality to ascertain whether the prescribed ambient air quality standards are violated. 5.4 AIR QUALITY MONITORING DURING DIWALI FESTIVAL

Ambient Air Quality Data/Results:




Fig. 5.4.0 Air quality at MUDA Complex, Police Bazar during Diwali festival.

The findings of the monitoring results indicated that the concentrations of SO2 and NOx at both the locations i.e. MUDA Complex, Police Bazar and Board's Premises, Lumpyngngad were found to be within the prescribed limits of National Ambient Air Quality Standards during Pre- Diwali, Diwali and Post- Diwali. However the concentration of PM10 was found to be above the permissible limits during Diwali day at MUDA Complex, Police Bazar. Monitoring results are shown in Table 5.9 and depicted in Fig. 5.4.0 and 5..4.1.




Fig. 5.4.1 Air quality at Board's Premises, Lumpyngngad during Diwali festival.



5.5 ASSESSMENT OF VEHICULAR POLLUTION

The Board has an Auto-emission-testing centre in its office premises at Lumpyngngad, Shillong which has been functioning since January 1994. This Centre caters to the exhaust testing needs for the commercial and private light petrol and diesel driven vehicles only.

As per arrangement with the Office of the Commissioner of Transport, Meghalaya, the periodical renewals of permits of taxis are subject to submission of "Green Certificates" issued from the Office of the Board. During the year 2011-2012, the number of vehicles tested at the Centre is as follows:-

5.6 NOISE LEVEL MONITORING

The Meghalaya State Pollution Control Board, Shillong, conducted Ambient Noise Level tests during the Diwali festival on the 20th (before Diwali) and the 26th (Diwali day) of October 2011. The monitoring was in pursuance to the Government of India's Notification and the interim directions of the Hon'ble Supreme Court.

5.6.1 Study Area

The city selected for the above monitoring is Shillong, being the largest city and the capital of Meghalaya. The city is cosmopolitan, having a sizeable portion of its residents celebrating Diwali. The two locations selected in the city are Police Bazar (at the Meghalaya Urban Development Authority complex) and Lumpyngngad (at the Meghalaya State Pollution Control Board's premises).

5.6.2 Instrument used and methodology

The monitoring team was equipped with a Larson-Davis DSP 80 and a Lutron SL-4001 Sound Level Meters. The noise levels were measured in dB (A) i.e. the level of sound in decibels on scale – A, as per the human ear sensitivity requirements. The result was expressed in Lmin, Lmax and Leq, wherein Lmin indicates the minimum value of the sound level in decibels and Lmax the maximum value of sound level in decibels occurring during the single event and Leq denotes the A weighted energy mean of the noise level averaged over the measurement period.

The noise level was monitored for continuous 6 hours duration i.e. from 18:00 hours (i.e. 6:00 P.M.) to 24:00 hours (i.e. 12:00 P.M.) where Lmin, Lmax and Leq readings were recorded for every hourly interval. This was as per the Protocol specified by the CPCB, Delhi.



5.6.3 Findings

5.6.3.1 Location A (Lumpyngngad)

As observed in the Table 5.6.3.1 for Location A (Lumpyngngad), the monitored ambient noise level on a normal day (i.e. the 20th of October 2011) from 18:00 Hrs. (6:00 P.M.) to 22:00 Hrs. (10:00 P.M.) and from 22:00 Hrs. (10:00 P.M.) to 24:00 Hrs.(12:00 A.M.) is well within the standard limits of 55.0 dB (A) Leq for day and 45.0 dB(A) Leq for night time respectively.

On Diwali day (i.e. 26th of October 2011) however, it is observed that overall the average equivalent noise level (Leq) is comparatively higher than that on the normal day. As per the monitored observations, the timing between 18:00 Hrs. (6:00 P.M.) to 19:00 Hrs. (7:00 P.M.) and 21:00 Hrs. (9:00 P.M.) to 22:00 Hrs. (10:00P.M.) displays noise level above the daytime residential standard limits of 55.0 dB(A) Leq. The cause of such inflated noise level on Diwali day can only be attributed to the bursting of firecrackers and burning of sparklers etc. on the occasion.

5.6.3.2 Location B (Police Bazar)

As observed in the Table 5.6.3.2 for Location B (Police Bazar), the noise level on a normal day (i.e. on the 20th of October 2011) is within the standard limits of 65.0 dB (A) Leq (daytime) for such timings as 18:00-19:00 Hrs., 19:00-20:00 Hrs. and 21:00-22:00 Hrs. However, it is above the same standards during such timings as 20:00-21:00 Hrs. Again during the time slot from 22:00 Hrs. (10:00 P.M.) to 23:00 Hrs. (11:00 P.M.) the noise level is slightly above the night time standard limit of 55.0 dB(A) Leq. The higher level of sound monitored is due mainly to vehicular noise including horn noise.

On Diwali day (i.e. the 26th of October 2011), it is observed that the overall average equivalent noise level (Leq) is comparatively higher than that on the normal day. For all timings between 18:00 Hrs. (6:00 P.M.) through to 24:00 Hrs. (12:00 midnight), the monitored sound level is above the standard limits of 65.0 dB(A) Leq for daytime (up to 22:00 Hrs.) and 55.0 dB(A) Leq for night time (from 22:00 Hrs. onwards). As noted from the Leq, Lmin and Lmax, it can be inferred that the cause for the higher ambient noise level on Diwali day can only be attributed to the bursting of firecrackers and burning of sparklers etc. on the occasion.

Therefore, from the above findings it is observed that bursting of crackers etc. contributes to the overall increase in the environment. The same will definitely have a mental and physiological affect on residents who are 'compelled' or 'forced' 'listeners and hearers' of the emitted sound. Besides this, there is an increase in the suspended particulate matters and chemicals etc. due to the bursting and burning of crackers, sparklers, etc. However, the ban on the sale or use of high sounding firecrackers [generating noise level exceeding 125 dB(AI) or 145 dB(C)pK] have gone a long way in reducing the level of noise emitted during celebration of the festival.

5.7 MONITORING OF WATER QUALITY

5.7.1 Water Quality Monitoring Network

One of the main functions of the Board is to monitor the water quality of water bodies so that a comprehensive programme for prevention and control on abatement of water pollution can be planned. Keeping this in view the Meghalaya State Pollution Control Board is monitoring the water quality of the following 8(eight) surface water bodies and 5(five) ground water bodies in the state, under the National Water Monitoring Programme (NWMP), sponsored by CPCB. The monitoring is done on quarterly basis in surface water and Half Yearly in case of ground water.

5.7.2 Water Quality of the monitored water bodies.

5.7.2.1 Physico-chemical & bacteriological parameters of Surface Water Quality

Umiam Lake: The level of the Dissolved Oxygen values is meeting the desired class throughout the year. The Biochemical Oxygen Demand value is above 3 mg/l which is found to be above the desired limit, ranging from 2.5 to 12.0 mg/l. The organic pollution examined in terms of Biochemcial Oxygen Demand & Coliform Count indicates the extent of water quality degradation. Similarly, Total and Faecal Coliform which indicate presence of pathogens in water are also of major concern. The concentration of Dissolved Oxygen, Biochemical Oxygen Demand, Total and Faecal Coliform of the monitoring station is depicted below.




Fig 5.7.2.0 : Concentration of Dissolved Oxygen and Bio-Chemical Oxygen Demand of Umiam Lake





Fig 5.7.2.1:

Ward's Lake: The monitoring results obtained during the year 2011 revealed that the level of the Dissolved Oxygen values is meeting the desired class throughout the year and it range from 6.2 to 8.0 mg/l. The Biochemical Oxygen Demand value ranged from 5.5 to 9.0 mg/l which is found to be above the desired limit of 3 mg/l. The monitoring data results indicate that the organic and bacterial contaminations are the main critical pollutant in the water body. The concentration of Dissolved Oxygen, Biochemical Oxygen Demand, Total and Faecal Coliform is presented below.






Fig 5.7.2.2: Concentration of Dissolved Oxygen and Bio-Chemical Oxygen Demand of Ward's Lake




Fig 5.7.2.4: Concentration of Dissolved Oxygen and Bio-Chemical Oxygen Demand of Umtrew River





Fig 5.7.2.5:





Fig 5.7.2.6: Concentration of Dissolved Oxygen and Bio-Chemical Oxygen Demand of Kyrhuhkhla River





Fig 5.7.2.8.: Concentration of Dissolved Oxygen and Bio-Chemical Oxygen Demand of Thadlaskein Lake







Fig 5.7.2.10: Concentration of Dissolved Oxygen and Bio-Chemical Oxygen Demand of Myntdu River






Fig 5.7.2.14:

5.8 Analysis Of Water Samples Received From Government Private Agencies

In addition to the regular programme, the Board is also engaged for analysis of water samples etc. received from government departments, private agencies and research scholars. A total of 389 samples were tested during the year.



PRESENT STATE OF THE ENVIRONMENTAL PROBLEMS AND COUNTER MEASURES

eghalaya is a Hill State located in the North-Eastern region of the Country. It covers an area of about 22,429 Sq.kms. and its population as per 2001 census is 23, 06,069. Due lack to certain factors, the industrial development in the State has been slow and as such, the environmental pollution from industrial sources is not that significant. However, In the recent past, the growth of industries in the State has increased to a certain extent from small scale stone crushing unit to large scale cement industries which gave rise to the impact of the ecological imbalance in the State has been experiencing rapid population growth and fast urbanization. It is estimated that about 80% of the pollution is caused by the indiscriminate discharge or disposal of domestic sewage, trade effluents, urban solid wastes, bio-medical wastes; by domestic fuel burning and by vehicular exhaust emissions. However, the exhaust emissions from vehicles are the major contributors to air pollution since road transport is the only mode of transport in the State. Meghalaya is rich in mineral resources and the main minerals are coal and limestone, which are found in almost the entire southern belt. Mining activities are mostly in private hands and as such coal and limestone are being exploited in an unscientific and unplanned manner without any measures for reclamation of mined areas. Such mining activities have been causing severe water pollution and environmental degradation in the mining areas.

The Board has identified 1384 polluting industrial units/establishments in the State and most of these are small and tiny units. Under large-scale industrial sector there are 12 cement plants, which also falls under the 17 categories of highly polluting industries. The others are medium and small-scale industries such as Power Plants lime calcination plants, ingot manufacturing and steel rolling mills, Ferro alloys manufacturing unit, stone crushing units, auto workshops, auto servicing units, D.G. Sets etc. Most of the lime calcination units are coal – fired and kilns are of traditional types (pajwa), which do not have even hood and chimney for venting out the smoke. So far, no cost effective pollution control system could be suggested for such units due to the peculiar nature of the kiln structures, the type of coal used and the climatic condition at the places where such unit are dominantly located.

The Board is regulating the discharge of effluents and air emissions from industries through the issuance of Consents to Establish/Operate under Water & Air Acts. While issuing Consents, conditions are being imposed with regard to the effluent and the emission standards to which



industries have to comply with. Conditions are also stipulated for setting up effluent treatment plants and/or installing of air pollution control systems whenever they are found necessary. The Board periodically collects and analyses effluent samples for verification of compliance to the consent conditions by industrial units. The industries are also instructed to ensure that pollution control systems, whenever necessary, are installed and commissioned within a stipulated period. In respect of new Projects, "Consents to Establish" are issued only after examining the suitability of the sites and scrutiny of the pollution control proposals. Besides, the Board is encouraging the industries to adopt cleaner production techniques based on re-cycle, re-use, and recover concepts.

During the year 2011-2012, the Board received 71 nos., applications for grant of "Consent to Establish" small/medium industrial units under the Water (Prevention& Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981.Of these, 111 nos., were granted Consent to Establish.

The names of industries/firms which applied for Consent to Establish During the year 2011-2012 are as given at Annexure-4. Those industries that were granted Consent to Establish and its Renewal during the year are indicated at Annexure-4(A) and Annexure-4(B) respectively. The industries which were granted Consent to Operate is shown at Annexure-5.





ENVIRONMENTAL RESEARCH

During the year 2011-2012, the Board continued with the following study projects:-

A. Studies and Evaluation of Environmental and Socio-Economic Impact of Coal Mining in Jaintia Hills

The study work is still continuing during the current year.

B. Bio-Monitoring of Rivers in Meghalaya

The aim of the study is to obtain information about the state of ecological environment of water bodies, to assess the physic-chemical and bacteriological characteristics, to generate base line data on the aspects of bio-monitoring, and to plan control strategies for restoration of the pristine water quality of the water bodies. Final report is under preparation.

C. Ambient Air Quality Monitoring at Export Promotion Industrial Park (EPIP), Byrnihat The objective of the study is to determine the status and trends of ambient air quality, to ascertain whether the Ambient Air Quality of the area meets the prescribed standards, and to plan strategies for effective control of air pollution. The study work is continuing during the current year.

D. Assessment of Noise in Major Cities/Towns in the State

Under this study the ambient noise level quality at certain selected locations within the cities/towns of Shillong, Tura, Jowai, Nongstoin and Nongpoh is monitored for assessing the level at those areas. The aim of the study is to:

- (i) Get a represented scenario of the noise levels.
- (ii) Plan strategies to effective control of noise.

The study work is still continuing under the current year.

E. Assessment of Ground water quality and Ambient Air quality around Municipal Solid Waste Landfills

The objective of the study is to monitor the water quality of ground and surface water bodies located near the landfill site, to monitor the Ambient Air quality at the landfill and the vicinity. To monitor the quality of compost produced from the waste processing plant and the leacheate generated during the decomposition of original matter. Final report is under preparation.


9 ENVIRONMENTAL AWARENESS & PUBLIC PARTICIPATION

9.1 World Environment Day

On the occasion of World Environment Day 2011, the Meghalaya State Pollution Control Board organized a Free Vehicular Emission Testing Camp on 4th June 2011 at Additional Secretariat Parking Lot for petrol and diesel vehicles.

A total of 133 nos. of petrol driven vehicles and 50 nos. of diesel driven vehicles were tested (Annexure I & II). It was observed that out of 133 nos. of petrol driven vehicles tested 13.5% of petrol driven vehicles do not comply to the standard prescribed limits, whereas, out of 50 nos. of diesel vehicles tested 26% is the percentage not complying to the standard limits. The vehicle complying within the emission prescribed standards, were issued a "Green Certificate" with a validity of 6 months whereas the vehicles not complying to those prescribed standards were issued a "Red Certificate" and the vehicle owner has been advised to resubmit the vehicle after the same is repaired and serviced.

9.2 One –Day Workshop on Pollution Control and Waste Management

he Board is adopting the standards prescribed by the Central Pollution Control Board and Ministry of Environment and Forests, Government of India. In case, the Standards of the said organizations are not available the Board follows the standards prescribed by the Bureau of Indian Standards. The Board is maintaining the enforcement Schedule prescribed by the Central pollution Control Board and Ministry of Environment and Forests, Government of India in respect of 17 categories of industries. However, in case of other industries, it has its own enforcement schedule, which is specified at the time of granting of "Consent to Establish" and "Consent to operate".

OTHER ACTIVITIES OF THE BOARD

In addition to the main functions of the Board enumerated in the Water (Prevention and control of Pollution) 1974 and the Air (Prevention and Control of Pollution) Act, 1981 the Board also carries out the functions and activities under the Environmental (Protection) Act, 1986. The functions and activities carries out by the Board under Environmental (Protection) Act, 1986 are as follows:

11.1 Under the Hazardous Waste (Management Handling & Transboundary Movement) Rules, 2008, the Board;

- Issue of authorization for handling of hazardous waste to occupier and operators in the State.
- Preparation of inventory of hazardous waste generation in the State.
- Assisting the State Govt. in inventory of disposal sites and conduct of Environmental Impact studies.
- Monitoring of facilities/infrastructure/technical capabilities in hazardous wastes handling units.

11.2 Bio-Medical Waste (Management & Handling) Rules, 1998.

The Board, as the prescribed authority for implementation of the Rules has to perform the following functions & activities:-

- Inventorisation of sources generating bio-medical waste.
- Issuance of authorization to institutions generating bio-medical waste.
- Monitoring of compliance to the prescribed norms and standards for handling and management of bio-medical waste by the concerned institutions.
- Advice the Government for setting up of common facility for treatment and disposal of bio-medical waste.
- Enforcement of the provisions of the Rules in the State.
- Submission of Annual Status Report on management of bio-medical waste in the State.

Status of Bio-Medical Waste in the State for the year 2011-2012:-

- 1. The total number of Health Care Facilities in the state is 698
- 2. There are 5719 numbers of beds in the hospitals of the state.
- 3. The Total number of Bedded Hospitals is 169. Non-Bedded Hospitals (Dispensary/Sub-centers) is 439 numbers. While Veterinary Hospitals/Research Organisations/Clinics/Diagnostic Centres, Pathological Labs, etc., account for 90 numbers.
- 4. 27 numbers HCFs are utilizing Common Bio-Medical Waste Incinerator installed at Mawiong, Shillong by Shillong Municipal Board.
- 6. The total quantity of BMW generated per day is estimated at 679.10 Kgs.



11.3 Municipal Solid Wastes (Management & Handling) Rules, 2000

The functions of the Board under the Rules include:-

- Issuance of Authorization to the municipal authorities or the operator of a facility for setting up of waste processing and disposal facility and landfills.
- Monitoring the performance of waste processing and disposal facility including compliance with the standards in terms of ground water, ambient air, leachate quality, compost quality, etc.
- Submission of Annual Status Report on management of MSW in the State to the Central Pollution Control Board.

Status of Municipal Solid Waste in the state for the year 2011 - 2012 are:-

- 1. The total number of Municipal Authorities in the State is 7
- 2. Number of towns in the state is 16 (as per Census 2001).
- 3. The total number of Application received from Urban Local Bodies (ULBs) is 4 (four)and Authorisation granted is 2(two) while 2 (two) is under process.
- 4. Presently there is 1 (one) Vermicompost and 1(one) mechanical compost plant operating in the State.
- 5. There are 5(five) open dumping sites in the State while 1(one) landfill site has been identified.
- 6. There are no Waste-to-Energy projects so far.

11.4 Batteries (Management & Handling) Rules, 2001.

Under the Rules, the functions of the Board includes:-

- Preparation of inventory of Batteries Manufacturer, Importer, Re-conditioner, Assembler, Dealer, Re-cycler, Re-smelter & Auctioneer.
- Receipt of half-yearly returns of sales/buy back from manufacturer, importer, assembler and re-conditioner.
- Receipt of annual returns of recycling from the recyclers.
- Receipt of half-yearly returns from bulk consumers & auctioneer.
- Preparation and submission of annual compliance status report to CPCB.

During the year 2011-2012 there is no assembler, manufacturer, re-cycler or importer of lead acid batteries in the state. However, the Board has identified 33(thirty three) dealers and 82(eighty two) bulk consumers/auctioneers of lead acid batteries. These include State and Central Govt. offices/establishements, Military/Para-military establishments, State Transport Corporations, Health Care Facilities, University, Indutries and Companies in the state.



11.5 Plastic Waste (Management & Handling) Rules, 2011

Under the Rules, the Board is a prescribed authority for implementation of the Rules relating to manufacture and recycling of Plastics.

The activities of the Board includes:-

- Inventorisation of industrial units manufacturing carry bags and containers made of plastics.
- Grant of registration for manufacturing carry bags or containers made of virgin or recycled plastics.
- Monitoring the industrial units for compliance to the provision of the Rules.

The Board circulated to all Cement Plants operating in Meghalaya about the use of plastic wastes as co-fuel in Cement Plants as instructed by the CPCB and as tested in Madhya Pradesh.

11.6 Functions and Activities under Water (Prevention & Control of Pollution) Cess Act, 1977.

The function of the Board under the Act and Rules made thereunder is to assess and collect a cess from Local authorities/bodies and Industries consuming water for domestic and industrial purposes.

During the year 2011-2012 the total amount of Cess assessment is Rs 612537/- (Rupees six lakhs twelve thousand five hundred thirty seven) only and Cess collection is Rs. 254313/- (Rupees two lakhs fifty four thousand three hundred thirteen) The Cess collection is less to assessment in view of the fact that the local authorities' viz. SMB & GHADC and MeSEB has not made any payment to the cess bills submitted to them.

The Cess collected is remitted to the consolidated fund of India through Ministry of Environment & Forests, Government of India.

Plan Grants is received from State Government for various development activities. Grants and financial assissance is received from Ministry of Environment and Forest and Central Pollution Control Board, New Delhi for different projects and schemes.




Fig 13.1 Receipts and Expenditure during the year 2011-2012






