## "Workshop on Controlling and Mitigating Air Pollution for Obtaining Clean Air' on the occasion of 'International Day of Clean Air for Blue Skies' held on 06<sup>th</sup> September, 2024, at Aranya The Merian Resort, Killing Road, Ri-Bhoi

On the occasion of 'International Day of Clean Air for Blue Skies' the Meghalaya State Pollution Control Board (MSPCB), Forest & Environment Dept., Govt. of Meghalaya, organized a 'Workshop on Controlling and Mitigating Air Pollution for Obtaining Clean Air' on 06<sup>th</sup> September, 2024, at Aranya The Merian Resort, Killing Road, Ri-Bhoi.
