## PUBLIC NOTICE

### FINAL NOTICE FOR PAYMENT OF ENVIRONMENTAL COMPENSATION

Sub: Payment of Environmental Compensation and Property, Bank Accounts attachment-regd.

Whereas, the Hon'ble Tribunal, vide order dated 14/10/2020 and 29/10/2020 respectively in O.A. No 48/2019 (EZ)in the matter of "*Jitul Deka Vs Union of India & Ors*", had directed the State Government to assess the Environmental Compensation against the illegal mining/stone crusher units.

Whereas the Meghalaya State Pollution Control Board in compliance with above direction had imposed Environmental Compensation as per existing Rules/Guidelines on several illegal mining and stone crusher units. Despite reminders were served to above units, environment compensation payment had not been made by a majority of the units.

In view of the above, this is to inform the concerned parties that they have failed to make payment of the above Environmental Compensation even after they were given sufficient time and opportunities. Therefore, in compliance with the resolution of the meeting chaired by Chief Secretary to the Govt. of Meghalaya held on the 6<sup>th</sup> August, 2024, I am directed to inform them that an additional time of *14 (Fourteen) days only* from date of issue of this notice is hereby granted for making payment of above Environment Compensation, failing to comply with the direction for which attachment of their properties/bank accounts etc. shall be initiated by the competent authority under the provision of existing Rules/Laws/Guidelines as applicable to ensure recovery of Environmental Compensation at the earliest.

Please note individual letter has also been dispatched by registered Post to all concerned Parties.
