That M/s UMDUBA STONE QUARRY has applied for Environmental Clearance from the State Environment Impact Assessment Authority and that a Public Hearing is required in pursuance to **MoEF&CC O.M. No. L 11011/175/2018-IA-II(M). Dated: The 12th December, 2018** and is to be conducted in accordance to procedure laid down under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.
