PUBLIC NOTICE

It is brought to the notice of all concerned that **MANGGAPARA STONE MINE** of **Shri. Kingkong Ch Marak** has proposed a Boulder Stone Mine over an area of **1.0 Ha** falling under cluster with total area of **6.657 Ha** at **Manggapara, West Garo Hills** district, Meghalaya. The Proponent has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.

In pursuance to the provisions of Para 7(i) III of the above Notification, the Deputy Commissioner, WestGaro Hills District, Tura has vide letter No. PA/DLTF/IM/02/300, Dated Tura, the 12th March, 2024 fixed the date of the **PUBLIC HEARING** to be held at **Manggapara, West Garo Hills** on the **10th May, 2024** at **11:00 AM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
