It is hereby brought to the notice of all concerned that **NEHLANG LYNGDOH COAL BLOCK** has proposed Coal Mine over an area of 100 Ha. located at Lumiakhi- Wahsarang, Khliehriat C&RD Block, East Jaintia Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority (SEIAA), Meghalaya, Shillong as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14<sup>th</sup> Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1<sup>st</sup> December 2009 respectively.
