## PUBLIC NOTICE

It is hereby brought to the notice of all concerned that **SARYNGKHAM A COAL MINE** has proposed Coal Mine over an area of **148 Ha.** located at Byndihati Village, Saryngkham (Coal block-A) Khliehriat C & RD block East Jaintia Hills District. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority (SEIAA), Meghalaya, Shillong as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14<sup>th</sup> Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1<sup>st</sup> December 2009 respectively.

In pursuance to the above Notification, the Member Secretary of the Meghalaya State Pollution Control Board has fixed the date of the **PUBLIC HEARING TO SARYNGKHAM A COAL MINE** vide letter No. MPCB/TB-360/2024/SARYNGKHAM/2024-2025/2 Dtd.
