It is brought to the notice of all concerned that **Rikaleng Limestone Mine** of **Smt. Kuntimai Tangdhara** has proposed Limestone Mine over an area of 2.3125 Ha. located at Sohbar Village, Sohbar Sirdarship, East Khasi Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14<sup>th</sup> Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1<sup>st</sup> December 2009.
