PUBLIC NOTICE

It is brought to the notice of all concerned that **Tharia Limestone Mine** of **Smt. Seisoh Syiemlieh** has proposed Limestone Mine over an area of 3.375 Ha. at Tharia, Sohbar Sirdarship, East Khasi Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.

In pursuance to the above Notification, the Member Secretary of the Meghalaya State Pollution Control Board vide letter MSPCB/TB/360/2025/Tharia/EKHD/2024-2025/4, Dated: Shillong, the 04th March, 2025, has fixed the date of the **PUBLIC HEARING** to be held at the project site, **Tharia, Sohbar Sirdarship, East Khasi Hills District, Meghalaya** on the **03rd April, 2025 at 01:00 PM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
