PUBLIC NOTICE

It is brought to the notice of all concerned that Office of **Chief Executive Officer, Shillong Municipal Board, Shillong** has proposed to establish "**Integrated Municipal Solid Waste Management Facility including a new sanitary landfill site for Shillong**" located at **Nonghali Village, East Khasi Hills District, Meghalaya**. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.

In pursuance to the above Notification, the Member Secretary of the Meghalaya State Pollution Control Board vide letter No. MSPCB/TB/360/2024/EKHD/2024-2025/2, Dated: Shillong, the 06th December, 2024 has fixed the date of the **PUBLIC HEARING** to be held at the project site, **Nonghali Village, East Khasi Hills District, Meghalaya** on the **09th January, 2025 at 11:00 AM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
