It is brought to the notice of all concerned that Lynti Dkhar Limestone Quarry of Shri. Nebarson Tymmenniang has proposed Limestone Mine over an area of 1.24 Ha. at Ru- Ing, Sohbar Sirdarship, East Khasi Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.
