PUBLIC NOTICE

It is brought to the notice of all concerned that **Lynti Dkhar Limestone Quarry of Shri. Nebarson Tymmenni** has proposed Limestone Mine over an area of 1.24 Ha. at Ru- Ing, Sohbar Sirdarship, East Khasi Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.

In pursuance to the above Notification, the Member Secretary of the Meghalaya State Pollution Control Board vide letter No. MSPCB/TB-360/2025/LYNTI DKHAR/NEBARSON/EKHD/2025-2026/5 Dated: Shillong, the 10th July, 2025, has fixed the date of the **PUBLIC HEARING** to be held at the project site, Ru- Ing, Sohbar Sirdarship, East Khasi Hills District, Meghalaya, on the **14th August, 2025 at 11:00 AM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
