It is brought to the notice of all concerned that "Mooiong Thlusniang Limestone Mine" by M/S Meghalaya Cements Limited has proposed Limestone Mine over an area of 26.50 Ha (AML) located at Chiehruphi Village, Khliehriat, East Jaintia Hills District.
