PUBLIC NOTICE

It is brought to the notice of all concerned that **Riewsiar Limestone Mine of Shri. Arbis Thangdhara and Rusiar Limestone Mine of Smt. Seisoh Syiemlieh** has proposed Limestone Mine over an area of 0.47 Ha. and 1.0 Ha. respectively which form a cluster at Lynti Dkhar Area Sohbar, Sohbar Sirdarship, East Khasi Hills District, Meghalaya. The applicants have applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.

In pursuance to the above Notification, the Member Secretary of the Meghalaya State Pollution Control Board vide letter No. MSPCB/TB/360/2025/2025-2026/4-A, dated: Shillong, the 08th September, 2025, has fixed the date of the **PUBLIC HEARING** to be held at Lynti Dkhar, Area Sohbar Sohbar Sirdarship, East Khasi Hills District, Meghalaya, on the **08th October, 2025 at 11:00 AM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
