## **PUBLIC NOTICE**

It is brought to the notice of all concerned that **Shillong Airport Umroi of Airports Authority of India** has proposed **Expansion of Barapani (Shillong) Airport including Runway Extension, Expansion of Terminal Building and Apron and other Allied works**, at Shillong Airport, Umroi, Ri- Bhoi District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14<sup>th</sup> Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1<sup>st</sup> December 2009.

In pursuance to the above Notification, the Member Secretary of the Meghalaya State Pollution Control Board vide letter No. MSPCB/TB/360(2018)/2025-2026/28, Dtd: Shillong, the 04<sup>th</sup> September, 2025, has fixed the date of the **PUBLIC HEARING** to be held at the project site at Shillong Airport, Umroi, Ri- Bhoi District, Meghalaya, on the **07<sup>th</sup> October, 2025 at 11:00 AM** to record the views, suggestions, objections, etc. put forward by the concerned local affected persons.
