PUBLIC NOTICE

It is brought to the notice of all concerned that **M/S GOLDSTONE CEMENTS LTD.** has proposed to set up a Limestone mine & Clay Deposit over an area of 6.7892 Ha. located at **Umtyra Village, Chiehruphi, East Jaintia Hills District, Meghalaya**. The Company has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.
