PUBLIC NOTICE

It is brought to the notice of all concerned that **M/S FALGUNI WARISA BOULDERSTONE MINE OF SMT. FALGUNI WARISA** has proposed to set up a Boulder Stone Mine over an area of **2.61 Ha** at **UMDUBA, RI-BHOI DISTRICT**, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to **MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12th December, 2018**.

In pursuance to the provisions of Para 7(i) III .I.A. of Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. 
