It is brought to the notice of all concerned that **M/s AILADMON JAPAN** has proposed to set up a Limestone Mine over an area of 2.40 Ha. at Ka Ri- U Syiar, Lynti Dkhar Area, Sohbar Sirdarship, East Khasi Hills District, Meghalaya. The applicant has applied for prior Environmental Clearance from the State Environment Impact Assessment Authority in pursuance to **MoEF&CC O.M. No. L-11011/175/2018-IA-II(M) dated 12th December, 2018.**
