Mawkhain, Near Ichamati Village, Elaka Mawlong Sirdarship, East Khasi Hills District, Meghalaya. The Company has applied for prior Environmental Clearance from the Ministry of Environment Forest & Climate Change, New Delhi as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14th Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1st December 2009.
