## PUBLIC NOTICE

It is brought to the notice of all concerned that **MEGHALAYA ENERGY CORPORATION LTD.** has proposed to set up a (3x80 MW) Umngot Hydroelectric Project near the Village Siangkhnai, East Khasi Hills District, Meghalaya. The Corporation has applied for prior Environmental Clearance from the Central Government in the Ministry of Environment & Forests as required under the E.I.A. Notification, 2006 (S.O. 1533 (E) dated 14<sup>th</sup> Sept. 2006) and amendment E.I.A. Notification No. S.O.3067 (E), dated 1<sup>st</sup> December 2009.
